Tent and Camping site Rules and Regulations For the Camping site on the Aller sea in Wolfsburg

Dear Camping Guests

You are very welcome to be here on our camping site.

We are happy to have you here and wish all our guests a happy stay.

We will try to make your stay as pleasant as possible.

If you have any problems please do not hesitate to contact the staff.

We ask you while staying here not to do anything that could upset other guests at the site, to ensure your stay is a good and restful stay please take note of the following.

- 1.) On arrival please go along to the reception area taking your passport with you to be registered.
- 2.) The costs for the use of the camping site and its facilities are made by the owner of the site.
- 3.) Your camping space will be given and shown to you by our maintenance staff. A change of the allocated area can only be done with the approval of our staff. Please make sure that a space of at least 3 metres between caravans and mobile homes are kept.
- 4.) Camping guests must abide the few rules on the site, naked bathing and sunbathing is not allowed or the site.
- 5.) All facilities should be handled with care. The cutting of branches and the hedges is not allowed. Campers are requested to dispose of oversized waste at there own cost. Sewage and dishwashing water must be caught in a suitable utensil and must be emptied in the respective marked area it is not allowed to let sewage drain into the ground. Water must only be taken from the water marked area it is not allowed to waste water example watering the grass car washing etc. Please do not dig ditches or holes or put up lines or hinder with stones poles. For safety reasons please do not put tent and camping lines any nearer than 50cm. To the pathways. All electrical and gas appliances must be of approved standards. gas appliance must be in accordance with camping bye laws and must be checked regularly if required you will be asked by our staff to show a certificate of approval.
- 6.)Noise of any kind is not allowed between 1300 hours and 1500 hours or from 2200 hours and 0700 hours these times are for resting periods at midday and night times. To enforce this the entrance gates will be closed during these times. A camper is not entitled to cut his rent if disturbed by other campers this will be investigated by the management. In case of emegency during these times please do not hesitate to contact our staff. In the pre and after season there are exceptional times.
- 7.) please note also the following.
 - A.) cars motorcycles and bicycles should be parked alongside the tent or caravan. Because of the children and noise it is only allowed to drive at walking speed. Persons who ignore this may be banned from driving on the site. If you park your car etc. on an empty camping space you may be charged for this.
 - B.) Open camp fires are not allowed gas grills however may be used.
 - C.) Campers must keep everything in such an order that in case of emergency the site can be cleared as soon as possible.
 - D.) All campers must keep there area clean and tidy.

- E.) On the day of departure campers are requested to clean and clear there area by 1200 hours And then report to reception.
- F.) Campers may use all facilities on the site at there own risk.
- 8.) Dogs must be kept on leads at all times and kept in such a way they that they do not disturb or become a nuisance to other campers. No animals are allowed into the washing facilities. Extrimeties must be cleaned up straight away by the owners. If pets become a nuisance the owner may be asked to remove them from the camping site. the rent will not be reduced if this does happen.
- 9.) Buses bus trailers Mobile houses etc are not allowed to be parked on the camping site.
- 10.) Instructions from the management and staff must be followed not doing this could lead to being banned from the site.
- 11.) after being to reception and have been handed a copy of this you agree to abide the rules and regulations. Campers use the site at there own risk and no compensation will be paid for accidents or damage caused by flooding.
- 12) The renting of a caravan or tent to a third person is commercial and not allowed this must be approved by the TVDN.
